# Why crime rate against Dalits increasing in Madhya Pradesh: Congress jabs PM Modi

The Congress accused Prime Minister Narendra Modi on Friday of protecting those responsible for the paper-leak and recruitment "scams" in Madhya Pradesh and asked him why the crime rate against Dalits is "increasing" in the

Congress general secretary Jairam Ramesh hit out at the Bharatiya Janata Party-led Centre ahead of Modi's rally in Damoh in Madhva Pradesh.

"Today's questions for PM Modi as he heads to MP: Who is the PM protecting in MP's paper leak and recruitment scams? Why has the BJP let down Adivasis in Forest Rights Act implementation? MP has the highest crime rate against Dalits. Why is it increasing?" Ramesh asked in a post on X.

Elaborating on what he said were details of "jumlas" (rhetoric), the Congress leader said the government might have changed the name of the Employees Selection Board in Madhya Pradesh but nobody has forgotten the notorious Vyapam "scam" that rocked the state 10 years ago.

"Just last year, allegations broke out of a scam in the patwari recruitment examination. Seven of ten toppers in the examination came from the same exam centre in Gwalior which is owned by a BJP MLA. A few years earlier, in 2021, three tests -- for agriculture extension officers, senior agriculture officers and nursing staff -were cancelled when the evidence of foul play became too obvious to ignore," Ramesh said.

He said a probe subsequently found out that the papers for the exams were leaked by a private company that was already implicated in the Vyapam the 57,948 sq. km eligible for community rights," Ramesh alleged.

Why have the successive BJP governments in Madhya Pradesh failed to provide the Adivasi communities their rights, he asked.

Citing data compiled by the National Crime Records Bureau (NCRB), the Congress leader pointed out that Madhya Pradesh has the highest crime rate against Dalits in the coun-

"In 2021 (the latest year for which data is available), the crime rate against SCs was 63.6 as compared to the national average of 25.3. The state also recorded high crime rates against Dalits in 2019 and 2020 -- 46.7 and 60.8 against the national averages of 22.8 and 25 respectively. It is disgusting and shameful that the rate of crimes against Dalits has actually increased year-onyear," he said.

"The BJP has been in power in MP for more than two decades now. Why is it that Dalits have to increasingly fear for their safety? Does PM Modi feel no shame for the countless atrocities that Dalits have endured under his watch?" Ramesh asked and said the prime minister should break his silence on the is-

## Arvind Kejriwal accuses Enforcement Directorate of being 'petty', 'politicising' his food before court

**Accusing the Enforcement** Directorate of being "petty" and "politicising" what he ate in jail, Delhi Chief Minister Arvind Kejriwal on Friday asserted before a court that the food he consumed was in conformity with the diet chart prepared by his doctor.

The ED had on Thursday claimed before the court that Kejriwal was eating food high in sugar like mangoes and sweets every day, despite having type 2 diabetes, to create grounds for medical bail.

counsel Kejriwal's launched a spirited assault on the federal anti-money agency over its claim that the AAP national convenor was eating food laden with sugar so he can fall ill and seek bail on medical grounds. "ED claimed that I want to increase my blood sugar levels to get bail. Am I going to risk paralysis to get bail? Whatever food I have is as per the diet chart prepared by my doctor prior to arrest," Senior Advocate Abhishek Singhvi told the

Referring to the ED's



claim about the politician eating mangoes, sweets, aalo-poori etc regularly, he said these were provided to him only a few times.

"The allegation is that I have been consuming mangoes... Out of 48 meals sent from home, only three times mangoes were there. No mangoes have been sent after April 8. Mangoes have been made to look like sugar bullets. Their sugar level (glycemic index) is much less than brown rice or white rice," Singhvi told the court.

Kejriwal has been allowed to have food cooked at home in jail.

"I only use sugar free (an artificial sugar brand) in my tea. How petty, political Their statements are completely false and malicious. Just because you have a lot of influence in the media you are able to publish that I am having aaloo puri even though this meal was sent only once during pooja," he told the court.

Kejriwal, who had on Thursday withdrawn a petition for consulting his doctor thrice a week about his fluctuating sugar levels, moved a fresh plea on Friday seeking consultations with his physician for 15 minutes every day.

"Just because I am a prisoner do I have no right to a dignified life and good health? Am I a gangster that I cannot even be alVC (video conference) consultation with my doctor? We have had democracy for 75 years but I am seeing such an approach for the first time. Never seen such kind of pettiness," Singhvi said, reproachfully.

The ED opposed Singhvi's submissions, claiming the food Kejriwal was eating did not match the diet chart prescribed by his doctor. It said Tihar jail had sufficient medical facilities to take care of Kejri-

The ED's contentions were opposed by senior advocate Ramesh Gupta, who also appeared for Kejriwal.

"What has ED got to do with this hearing? He (ED) is not a party. It is between me and jail and court? They are having a media trial and press is publishing anything it wants," the counsel told the court.

The court reserved its order on Kejriwal's application seeking daily consultation with his doctor for Monday and directed Tihar jail authorities to file a reply, if required, by Satur-

here." The teams working from village to village are in dozens, and comprise five to six persons each. Arya said they were "getting very good response". "This kind of campaigning can change



**NEW DELHI, APR 19:** The Supreme Court on Friday asked yoga guru Ramdev to implead the complainants, who have lodged cases against him over his alleged remarks against the use of allopathic medicines during the Covid pandemic, as party in his plea seeking stay of criminal proceedings.

The Patna and Raipur chapters of the Indian Medical Association (IMA) have lodged complaints in 2021 alleging Ramdev's remarks were likely to cause prejudice to Covid control mechanism and may dissuade people from availing proper treatment.

A bench of Justices MM Sundresh and PB Varale, which was hearing Ramdev's plea seeking stay on criminal proceedings, said he needs to implead the complainants for securing relief in the matter.

The bench granted liberty to Ramdev to implead the complainants and

#### Parties gear up for INDIA bloc rally in Ranchi on April 21

JAMSHEDPUR, APR 19: The ruling coalition in Jharkhand JMM-Congress-RJD along with the Left parties are gearing up to make the Ulgulan (revolution) Nyay Maharally scheduled on April 21 at Ranchi a historic one.
