On Wednesday, the Reserve Bank of India (RBI) barred Kotak Mahindra Bank from onboarding new customers through its online and mobile banking channels and issuing fresh credit cards with immediate effect after the regulator found "serious deficiencies" in the lender's IT risk

## Divya Pahuja murder case: Gurugram court rejects interim bail plea of main accused

24: A local court here on Wednesday rejected the interim bail plea of the main accused in the murder of ex-model Divya Pahuja, police said.

Abhijeet Singh's counsel had filed the bail application on his behalf on the medical grounds, they

In his petition, Singh had said that four of his teeth were removed on November 25 last year. The remaining have also deteriohave to be removed.

According to police, the counsel also said that Bhondsi jail, where Singh is lodged, does not have adequate facilities.

During the hearing in the court of Additional District and Session judge Virender



Malik, Dr Pooja, a dentist working in the jail hospital, said that some teeth of the accused have been extracted correctly while for other treatments, it can be done at PGIMS, Rohtak.

The court accepted that if treatment is not available in the hospital in Rohtak, then the accused can be taken to AIIMS in Delhi but considering the seriousness of the case, the court rejected the interim bail plea of the accused, a senior

police officer said.

Earlier in April, the Gurugram police had filed a chargesheet against seven people -- Singh, Ravi Banga, Hemraj, Prakash, Megha, Pravesh and Balraj Gill -- arrested

for Pahuja's murder.

On January 2, Pahuja was taken to Hotel City Point by five people and shot in the head because she had allegedly been extorting money from hotel owner Singh by blackmailing him with his "obscene

After Pahuja was murdered, Gill had allegedly kept her body in the trunk of a BMW car and later threw her body in the Bhakra Canal near Munak in Sangrur, Punjab.

Police said he carried out the alleged act with Banga at the behest of Singh who is also in judicial custody.

Pahuja's body was recovered from the canal on January 13, 11 days after she was killed. One of the accused,

Nadeem, is still at large.

## West Bengal govt moves SC against Calcutta HC order cancelling appointment of over 25,000 teachers

NEW DELHI, APR 24: had on Monday declared ment has moved the "null and void" and directed Supreme Court against the the CBI to probe the apment of 25,753 teachers and non-teaching staff made by the state's School Service Commission (SSC) in staterun and state-aided schools.

Challenging the high court order, the state government, in its appeal filed before the top court, said the HC cancelled the appointments "arbitrarily".

"The high court failed to appreciate the ramification of cancelling the entire selection process leading to straightaway termination of teaching and non-teaching staff from service with immediate effect, without giving sufficient time to the petitioner state to deal with such an exigency, rendering the education system at a stand-still," the plea said.

The Calcutta High Court

the selection process as agency to submit a report within three months.

The high court said those appointed outside the officially available 24,640 vacancies, appointed after the expiry of the official date of recruitment, and those who submitted blank Optical Mark Recognition (OMR) sheets but obtained appointment to return all remunerations and benefits received by them with 12 per cent interest per annum within four weeks.

Observing that it has given "anxious consideration to the passionate plea" that persons who had obtained the appointments legally would be prejudiced if the entire selection process is cancelled, the bench said it hardly had any

The high court held that all appointments involved were violative of Articles 14 in employment in any government office) of the Constitution

"It is shocking that, at the level of the cabinet of the State Government, a decision is taken to protect employment obtained fraudulently in a selection process conducted by SSC for statefunded schools, knowing fully well that, such appointments were obtained beyond the panel and after expiray of the panel, at the bare minimum," the high court had said.

It said unless "there is a deep connection between the persons perpetuating the fraud and the beneficiaries" with persons involved in the decision-making process, such action to create supernumerary posts to protect illegal appointments is "inconceivable".

The division bench had also rejected a prayer by Calcutta High Court order pointment process. It had (equality before law) and 16 some appellants, including invalidating the appoint- also asked the central (prohibiting discrimination the West Bengal School Service Commission (SSC), for a stay on the order and asked the commission to initiate a fresh appointment process within a fortnight from the date of the results of the ongoing Lok Sabha elections.

The bench, constituted by the Chief Justice of the high court on a direction of the Supreme Court, had heard 350 petitions and appeals relating to the selection of candidates for appointment by the SSC in the categories of teachers of classes 9, 10, 11 and 12 and group-C and D staffers through the SLST-2016.

In its 282-page judgment, the high court had said retaining appointees selected through "such a dubious process" would be contrary to public interest.

### AAP workers detained during protest against 'mistreatment' of Arvind Kejriwal in jaila

NEW DELHI, APR 24: Three AAP workers were briefly detained on Wednesday during a protest here at ITO Chowk against the alleged mistreatment of Delhi Chief Minister Arvind Kejriwal in Tihar Jail, officials said.

Kejriwal, the AAP's national convenor, is lodged in Tihar in connection with a money-laundering case linked to the Delhi government's now-scrapped excise policy. He was arrested by the Enforcement Directorate on March 21.

The protest was led by AAP MLA Kuldeep Kumar



as a dozen party supporters gathered at the AAP headquarters at ITO Chowk around 9 am. Some of the protestors were doctors who wore aprons, a police officer said.


NEW DELHI, APR 24: Alleging the Tihar Jail administration cancelled Delhi Minister Atishi's meeting with Chief Minister Arvind Kejriwal at the last moment, AAP Rajya Sabha MP Sanjay Singh on Wednesday said "even the British rule did not see this kind of behaviour".

According to Tihar official sources, Atishi's name was added after Delhi Health Minister Saurabh Bharadwaj's name into the list of visitors for Kejriwal. She will be meeting him on April 29. Sources said that Transport Minister Kailash Gahlot's name will also be added to the list of visitors and he will be meeting Kejriwal soon.

Addressing a press conference, Singh said that Bharadwaj and Atishi were supposed to meet the chief minister in Tihar.

"But Atishi's meeting was not confirmed yesterday. Delhi Education Minister Atishi applied for the meeting and at the last moment her meeting was cancelled," Singh said.

"After her meeting was cancelled, party national general secretary (organisation) Sandeep Pathak was supposed to accompany Bharadwaj, but he



am today that even his meeting was cancelled," he

Tihar sources said that Pathak himself did not

Singh questioned the reasons behind the move and feared that Kejriwal might not even be allowed to meet his wife in future.

"You are cancelling an MP's meeting, a minister's meeting with Kejriwal. You had cancelled my meeting with him earlier. Tomorrow you might cancel the meeting with his wife. Even the British rule did not see this kind of behaviour," he

### Allegation of conspiring against PM cannot be levelled irresponsibly, says Delhi High Court

**24:** Delhi High Court on Wednesday said allegations of conspiring against the prime minister amount to treason and cannot be levelled irresponsibly without any cogent material.

The court was hearing a lawsuit by BJD MP Pinaki Misra against lawyer Jai Anant Dehadrai over his allegedly defamatory tweets and statements, including that the lawmaker -- along with expelled TMC MP Mahua Moitra -- conspired against the prime minister.

Justice Jasmeet Singh observed that while a politician cannot be "sensitive", Dehadrai should await the outcome of his

complaint to the authorities and cannot be "trigger

Moitra was expelled from the Lok Sabha on December 8 following accusations by Dehadrai, her former partner, that she took bribes from businessman and Hiranandani Group CEO Darshan Hiranandani to ask questions in Parlia-

"When you say conspiracy against the prime minister, it is troublesome. You can't be trigger happy ... Conspiracy against the prime minister is an offence against the state, (it is) treason," the court said during the hearing.

Dehadrai and his counsel assured the court that he would not make further statements in relation to Misra "conspiring" against the prime minister till the next date of hearing. "Mr (Raghav) Awasthi,
