

### Modi breaks Indira Gandhi's record to become 2nd-longest serving PM of India

NEW DELHI, JULY 25: Prime Minister Narendra Modi will on Friday become India's second-longest serving premier in consecutive terms, completing 4,078 straight days in office, surpassing Indira Gandhi's uninterrupted tenure between 1964 and 1977, and is only behind the country's first PM Jawaharlal Nehru, a person aware of the matter said on Thursday.

Modi, 74, the first prime minister born in Independent India, was sworn-in for the third consecutive term in June last year, having first entered the top office on May 26, 2014. The Bharatiya Janata Party (BJP) leader is also the longest-serving PM from a non-Congress party.

On July 25, PM Modi will complete 4,078 days in office in three straight terms. "On this day, he (Modi) will become the second longest consecutive serving PM of India, surpassing Indira Gandhi, who was the PM



consecutively for 4,077 days, from January 24, 1966 till March 24, 1977," a person aware of the matter said.

Indira Gandhi had also served as the PM from January 14, 1980 until her assassination on October 31, 1984. Her father Jawaharlal Nehru remains the longest-

been in the office for 16 years and 286 days from August 15, 1947 till May 27, 1964.

Before becoming the PM, Modi was the longest-serving chief minister of Gujarat, having been in office from 2001 to 2014.

"He is the first and only non-Congress PM to comserving PM of India, having plete at least two full terms

as Prime Minister and to get re-elected thrice...He is also the first and only non-Congress leader to secure a majority on his own in a Lok Sabha election," the person quoted above said.

In 2014, the BJP stormed to power at the Centre with a brute majority of 272 seats, with Modi as the party's PM face. Five years later, the party improved its tally, winning 303 of the 543 Lok Sabha seats.

Although the BJP fell short of reaching the halfway mark in 2024, it emerged as the single largest party and formed the government for a third straight term with support of its NDA partners.

"He is the first sitting Prime Minister since Indira Gandhi (in 1971) to get reelected with a majority and the only Prime Minister, apart from Jawaharlal Nehru, to win three consecutive elections as leader of a party," the person added.

# Supreme Court Rejects Plea To Increase Assembly Seats In Andhra, Telangana

**NEW DELHI, JULY** lows delimitation only after **25:** The Supreme Court on Friday declined to issue a direction to the Centre to increase the number of Assembly seats in Andhra Pradesh and Telangana.

A Bench of Justices Surva Kant and N. Kotiswar Singh was dealing with pleas seeking implementation of the provisions under the Andhra Pradesh Reorganisation Act, 2014, which provided for delimitation of Assembly seats in the two successor states.

heart attacks: Nadda tells Lok Sabha NEW DELHI, JULY **25:** Union Health Minister J

Nadda said on Friday Covid vaccination had no effect on the risk of heart attacks.

In a written response to a question in Lok Sabha, he also clarified that data regarding heart attack cases is not maintained centrally.

Heart attack cases are not notifiable and there is no central registry for these.

The Indian Council of Medical Research (ICMR) has informed that in order to understand the reasons for heart attack, ICMR-National Institute of Epidemiology (ICMR-NIE) conducted a multi-centric matched casecontrol study in 25 hospitals across India.

Cases were patients aged 18-45 years admitted in the study hospitals with newly diagnosed Acute Myocardial Infarction (AMI) between October 2021 and January 2023, Nadda said.



Controls were patients aged 18-45 years admitted in being smoker.

"Receipt of vaccination against COVID-19 had no effect on the risk of AMI. Even in those without any comorbidities, family history of thrombotic events and ever smoking was associated with increased risk of AMI," he

The National Health Mission (NHM) provides technical and financial support to the states and Union territories under the National Programme for Prevention and Control of Non-Communicable Diseases (NP-NCD),

Nadda said. Cardiovascular disease is an integral part of NP-NCD. Under the programme, 770 district NCD clinics, 6410 community health centres NCD clinics and 233 cardiac care units have been set up. Further, a population-

based initiative for prevention, control and screening for common NCDs including diabetes and hypertension has been rolled out in the country under NHM as a part of comprehensive primary health care.

Under the initiative, people above 30 years of age are targeted for their screening, Nadda said.

"Come, there will be a dis-

cussion to end the stalemate. There will also be representatives from the government...If there is disagreement, it should be expressed as per house norms," Birla said.

Earlier in the day, Congress MP Manickam Tagore moved an adjournment motion notice to discuss the "Mass Disenfranchisement of 52 Lakh Voters in Bihar", which he called as a "deliberate assault on the constitution and democracy by the Modi Government using the Election Commission."

### Six students dead as portion of school building collapses in Rajasthan

JHALAWAR (RJ), JUL 25: A portion of a government school building collapsed in Rajasthan's Jhalawar district on Friday, leaving six children dead and 29 injured, police said

The children at the Piplod Government School in Manoharthana block of the district were assembling for morning prayers when the incident took place.

The police were informed at around 7:45 am.

Police said the children were pulled out of the debris with the help of teachers and villagers.

Five of the deceased have been identified as Kundar, Kanha, Raidas, Anuradha and Badal Bhil, Station House Officer, Manoharthana, Nand Kishore

#### said.

There were around 35 students in the building when the incident occurred, officials said.

Earlier Station House Officer at Dangipura police station Vijendra Singh had said that classes for 6 and 7 in the building gave away leading to the collapse.

Prime Minister Narendra Modi condoled the loss of lives in the incident.

In a post on X, he said, "The mishap at a school in Jhalawar, Rajasthan, is tragic and deeply saddening. My thoughts are with the affected students and their families in this difficult hour".

"Praying for the speedy recovery of the injured. Authorities are providing all possible assistance to those affected,"

#### he added.

Condoling the loss of lives, Chief Minister Bhajanlal Sharma said, "The concerned officials have been directed to ensure proper treatment of the injured children." "May God grant a place to the departed divine souls in his lotus feet and give strength to the bereaved family to bear this immense sorrow," he said.

Education minister Madan Dilawar said a high-level inquiry will be conducted into the incident.

He directed officials to rush to the spot and ensure that the children get proper treatment.

"A very unfortunate incident occurred in Piplod village in Jhalawar where roof of a school collapsed.

#### HYDERABAD, JUL 26: ISRO Chairman V Narayanan on Friday said that India has to nearly triple its number of satellites in space, from the current 55, within the next three years.

Delivering 'The GP Birla Memorial Lecture on Indian Space Programme -Accomplishments, Challenges and Future Perspectives', Narayanan said by 2040 India would be on par with any other nation in terms of space technology, application area, and infrastructure.

He also said as many as 12 launch vehicle missions are planned by the ISRO this year. The upcoming mission, NASA-ISRO Synthetic Aperture Radar

"Now we are working on building our own space station. We are going to have our own Chandrayan landing. Right

now, 55 satellites are in orbit serving the common man in this country. And in another three years, this number has to become almost three times. The requirement is huge. The demand is so much that we have to build satellites. We are working towards that," he said.

Later, talking to reporters, he said that in 2035 India will build a full space station, and the first module will be placed in orbit in 2028.

Narayanan said, as far as space sector reforms are concerned, a lot of work is going on and earlier ISRO's model of work used to be service-oriented, but now it wants to grab business opportunities.
