Omar visits fire-ravaged village, tells victims they aren't alone in this difficult time

Abdullah, who took over as the first chief minister of the Union Territory on October 16, said though the administration had already provided some sort of relief to the victims, he had passed directions for enhancing the relief.

"We have also initiated steps to seek relief from the Prime Minister's Relief Fund and are hoping to get the same. Additionally, we will also try to provide more relief," the chief minister said.

"It is my duty to reconstruct their homes," he said and added, "Homes will be rebuilt along with concrete bath-

Abdullah, who assumed office on October 16, said he had not come to the village for politics. "I have not come here for the sake of politics. We have to pull out the people from this destruction and we will be doing that," he as-

He met with the affected families, offering them his condolences and assuring them immediate relief, and longterm support to help them rebuild their lives.

"We are here to help you rebuild your lives. The district administration has already provided initial relief, and I have ordered additional support," he added.

In a bid to prevent similar incidents in the future, Abdullah announced the establishment of two new fire service stations in Warwan and Marwah areas. Additionally, he announced the construction of a proper road leading to the villages, ensuring better access and reducing the risk of fire-related disasters in the remote area.

"Our focus is on both immediate relief and long-term solutions. We must ensure that such tragedies are not repeated," the chief minister emphasised.

"Accordingly a case FIR No 13-2024 under section 7 of the Prevention of Corruption Act, 1988 (as amended in 2018) was registered against Sh Mubarak Ahmad Ganie, AEE PWD (R&B) Division Sopore, District Baramulla at PS ACB Baramulla &investigations were put into motion. During investigation, a trap team headed by Dy.SP rank officer was constituted at PS ACB Baramulla. The team laid a successful trap and accused AEE was caught red-handed while demanding and accepting bribe of Rs. 25000/- from contractor [complainant] at PWD R&B office sopore District Baramulla on 16-10-2024. Accordingly, after completing all legal formalities the accused AEE was arrested on the spot. The bribe money of Rs 25000/- was also recovered from his possession in the presence of independent witnesses, beside this during his personal search some cash was also recovered from his possession which is subject matter of further investigations."

"Subsequently residential house as well as official accommodation of the accused was also searched following due process laid down under law, during which incriminating documents were recovered & seized in presence of magistrate & independent witnesses. Meanwhile as mandated under law, the accused AEE was presented before the court of special judge anti-corruption court, Baramulla, and was remanded for 9 days police custody. Further investigation of the instant case is going on," the statement added.

"The formation of the Legislative Assembly before the restoration of statehood would violate the idea of federalism, which forms part of the basic structure of the Constitution of India," the plea said.

It said that the Valley always had a federal relationship with the Union of India. Thus, it is of utmost importance that the status of statehood is restored "so that they can enjoy an autonomy in their individual identity and also play an important part in the overall development of the Country.'

The plea further said, the general elections were also held without any such incidence or violence from April 19, 2024

It was also submitted that Jammu and Kashmir will also soon to hold Panchayat elections, in the coming months which shall also be conducted smoothly and in peaceful circumstances. Therefore, there is no impediment of security concerns, violence or any other disturbances which would hinder or prevent the grant/restoration of the status of Statehood to Jammu and Kashmir as had been assured by the Union of India in the present proceedings.

On December 11, 2023, the Supreme Court had unanimously upheld the revocation of Article 370 of the Constitution, which accorded a special status to the erstwhile state of Jammu and Kashmir, in 2019 and ordered that assembly elections be held there by September 2024. The court had also said that Jammu and Kashmir's statehood should be restored "at the earliest".

Hamas chief killed: Netanyahu

Earlier today, the Israel Defence Forces (IDF) confirmed that three terrorists have been killed during its operations in Gaza, among whom was Hamas chief Yahya Sinwar, who has now been confirmed dead.

IDF shared a post on X and wrote, "During IDF operations in Gaza, 3 terrorists were eliminated. The IDF and ISA are checking the possibility that one of the terrorists was Yahya Sinwar."

This development comes weeks after Israel killed another high-profile leader, Hezbollah chief Hassan Nasrallah, through airstrikes in Lebanon. Earlier, another senior Hamas leader, Ismail Haniyeh,

died in Iran. Though Tehran and Hamas have accused Israel of the attack, Israel has neither accepted nor denied the Recently, the IDF eliminated several high-ranking

Hamas officials, including Rawhi Mushtaha, Head of the Hamas government in Gaza, and Sameh al-Siraj, who held the security portfolio in Hamas' political bureau. On Tuesday, the IDF said some 20 Hamas operatives

were killed in airstrikes and close-quarters combat in Jabaliya over the past day, the Times of Israel reported. Troops also located and destroyed a weapons depot and other weapons amid the fighting, according to the mili-

"The operation will continue as long as necessary, while systematically striking and thoroughly destroying the terror infrastructure in the area," the military said.

On Monday, the IDF called on Palestinians in northern Gaza's Beit Hanoun, Jabaliya, and Beit Lahiya to evacuate to the Israeli-designated humanitarian zone in the Strip's south, as per the Times of Israel.

Meanwhile, on Tuesday, the IDF and Shin Bet security agency said that three Hamas terrorists who participated in the October 7 onslaught were killed in airstrikes in recent

HC to hear plea against LG's power to nominate 5 MLAs

Lieutenant Governor (LG) of Jammu and Kashmir to nominate five Members of the Legislative Assembly (MLAs) to the Jammu and Kashmir Assembly.

A bench consisting of Justices Sanjiv Khanna and PV Sanjay Kumar had, however, directed the petitioner to first approach the High Court of Jammu and Kashmir and Ladakh before seeking relief from the apex court.

"In many cases where we have entertained matters at first instance, we see that certain issues are overlooked," the bench observed, signalling that the High Court would be the appropriate forum to address the matter initially.

At the heart of the petition is a provision from the Jammu and Kashmir Reorganisation Act of 2019, which allows the LG to nominate five MLAs to the assembly, representing displaced Kashmiri people and residents from PoK.

The J&K Assembly currently has 90 elected members, and these additional nominations raise the majority threshold from 45 to 48.

Reduce overcrowding of jails: MHA writes to states, UTs shall be released on bond by the Court, if he has under-

gone detention for the period extending up to one-third of the maximum period of imprisonment specified for such offence under that law'.

The Section 479 (3) of the BNSS casts a specific responsibility upon the Superintendent of Prisons, where the accused person is detained, to make an application to the concerned court for release of such prisoners on bail.

The home ministry said the Supreme Court, in its order dated August 23, 2024, in 'Inhuman Conditions in 1382 Prisons' noted that the provisions of Section 479 of BNSS shall apply to all undertrials in pending cases irrespective of whether the case was registered against them before July 1, 2024, the date when the new law came into effect.

The Court has directed the Superintendents of Jails across the country that wherever accused persons are detained as undertrials, their applications may be preferred to the concerned courts, upon completion of one-half or one-third of the period mentioned in sub section (1) of Section 479, for their release on bail.

"All states and UTs are requested to take note of the specific legal mandate cast on the Superintendent of Prisons under their jurisdiction and disseminate this information to all relevant ranks, particularly the Superintendent of Prisons, and monitor the effective implementation of the new provisions of BNSS, as cited above," the communication said.

For assisting the state and UT prison authorities in quick identification of eligible prisoners, the ministry has made appropriate provisions in the national E-Prisons portal,

"The E-prisons portal has thus enabled the state Jail authorities to access the data of inmates in a quick and easy manner for identifying eligible inmates whose application needs to be moved to the court for their release on bail," the home ministry said. **Terrorists escape** after encounter ing towards the forest, leading to a brief firing, the officials added.
