2 killed as vehicle falls into gorge

Two youth were killed after the vehicle they were travelling in skidded off the road and plunged into a deep gorge in Dharangli Tote area of Reasi district of Jammu early this morning.

They were identified as Mannu, son of Rattan Singh, and Jagdev Singh, son of Balwan Singh. Both hailed from Shorai.

Officials said the incident took place in the early hours after the driver lost control over the vehicle on a hilly stretch of the road.

A rescue operation was launched immediately after the incident and the bodies were retrieved from the gorge, the officials added.

Modi warns NDA MPs against resting on laurels after poll wins

Urges them to stay grounded

NEW DELHI, FEB 03: Warning NDA MPs against resting on laurels after various poll wins and urging them to stay grounded, Prime Minister Narendra Modi today told them that 'the coalition has been winning various elections due to its people-friendly policies and hard work'.

PM Modi also told NDA MPs that they should not be complacent with their win in various polls, including local bodies, but continue with the good work, Parliamentary Affairs Minister Kiren Rijiju told reporters after the NDA Parliamentary Party meeting.

At the meeting, Modi was felicitated by the NDA leaders for successfully concluding trade deals with 39 countries.

Referring to the US and India agreeing on a trade deal under which Washington will bring down reciprocal tariff on Indian goods to



18 per cent from current 25 per cent, the minister said there is an excitement about it in the entire country.

"There is excitement among the MPs that these trade deals have been concluded under the leadership of PM. The trade deals have been signed with a total of

39 countries. This is historic. All these 39 countries are developed countries...This is historic. There has been a very good atmosphere in the country," he said.

Shiv Sena MP Milind Deora said, "PM Modi explained to all the MPs that

the government works in favour of India, be it a trade deal or budget".

"The credit for the trade deal between India and America and India and India-Europe goes to PM Modi. This has happened because of his determination.

Amid objections, govt halts 3 proposed railway projects in Kashmir

NEW DELHI, FEB 03: The railway ministry today said that three proposed railway projects in Kashmir had been put on hold, following objections from locals & elected representatives, who raised concerns over the large-scale land acquisition and its impact on apple orchards.

The decision comes amid protests by apple growers and residents in Pulwama, Shopian and Anantnag districts, voicing concern that these projects would affect the agricultural and horticultural land, damage orchards, and lead to the displacement of families.

Several demonstrations were held over the past months, with locals demanding rerouting of the projects, fair compensation, and consultation before any land acquisition.

Chief Minister Omar Abdullah welcomed the rail-

way ministry's decision to put three projects on hold in the valley, but requested an increase in the frequency and number of coaches of Vande Bharat trains operating between Katra and Srinagar.

Earlier in the day, NC's Pahalgam MLA Altaf Ahmad Wani informed the assembly that Railway Minister Ashwini Vaishnav had announced the decision to put three railway projects proposed to connect Srinagar with Pahalgam and Shopian on hold.

Kremlin dismisses Trump claim on India halting Russian oil purchases

MOSCOW, FEB 03: The Kremlin has reacted strongly to recent claims made by US President Donald Trump that India would cease importing oil from Russia.

Trump publicly asserted that Indian Prime Minister Narendra Modi gave him assurances that New Delhi would halt purchases of Russian crude, framing the alleged commitment as a significant development in efforts to economically isolate Moscow and reduce fuel for Russia's war in Ukraine.

Trump's remarks, delivered in Washington and reiterated in later comments, suggested India had "more

or less stopped" buying Russian oil and described such a shift as a "good step" in global energy diplomacy.

"So far, we haven't heard any statements from New Delhi on this matter," reports quoted Kremlin spokesman Dmitry Peskov as telling reporters.

Peskov said Russia valued its relationship with India and would continue to develop its strategic partnership.

"We respect bilateral US-Indian relations. But we attach no less importance to the development of an advanced strategic partnership between Russia and India. This is the most im-

portant thing for us, and we intend to further develop our bilateral relations with Delhi," he said.

Moscow's official response has been dismissive of what it described as Washington's pressure tactics and unfounded assertions. The spokesperson for the Kremlin made clear that the Russian government does not consider threats of tariffs or attempts to influence India's energy policy to be legitimate, underscoring the principle that sovereign nations have the right to pursue trade and economic cooperation based on their own national interests.

The operation was launched yesterday, following information about the movement of two to three terrorists, said to be affiliated with Pakistan.

Assembly witnesses uproar Oppn members raise demand for NLU in Jammu

Noisy scenes were witnessed in the assembly today as the opposition BJP members raised demand for the establishment of a National Law University in Jammu.

However, despite the uproar, Speaker Abdul Rahim Rather continued with the Question Hour.

As the assembly proceedings started, BJP MLA Surjit Singh Slathia drew the attention of the House towards the students of Jammu University who were on the roads for the past few days in support of the demand for a National Law University in Jammu.

"We are not against granting National Law University (NLU) for Kashmir but also want one such University for Jammu to fulfill the demand of the students of the region," he said.

While Slathia was speak-



ing, other BJP MLAs also stood up and displayed placards in support of the demand and also raised slogans like "NLU for Jammu".

Congress legislator Nizam-ud-Din Bhat objected to the display of placards and said the recent meeting of the business advisory committee had decided to maintain the decorum of the House while raising any issue.

"The action of displaying placards by BJP legislators is akin to encroachment and intrusion which is not acceptable. The govern-

ment granted permission for NLU in Kashmir following due process," he said.

Amid the ruckus, National Conference legislator Mubarik Gul alleged that Kashmiri students and traders were facing harassment and assault in different parts of the country.

PDP MLA Wahid Rehman Para said that he had moved an adjournment motion to discuss growing incidents of harassment of Kashmiri students and others.


