


DLSA Srinagar organizes awareness program on Scheduled Castes & Scheduled Tribes Act

District Legal Services Authority (DLSA) Srinagar conducted an awareness programme under the guidance of Haq Nawaz Zargar, Chairman DLSA, Srinagar and overall supervision of Secretary DLSA, Srinagar on the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 in tribal areas of Dara, Faqir Gujri Srinagar.

The programme was organized through Para Legal Volunteers (PLVs) and members of the Samvaad Committee with the aim of educating tribal communities about their legal rights and protections available under the Act.

During the programme, the resource person highlighted the key provisions of the Act, emphasizing its



safeguards provided to members of Scheduled Castes and Scheduled Tribes against atrocities, discrimination, and exploitation.

The participants were informed about the legal remedies available, the procedure for lodging complaints, and the role of legal aid institutions in ensuring

justice to victims.

The PLVs actively interacted with the local population and distributed informative material to enhance awareness regarding free legal services available through DLSA Srinagar. The members of the committee stressed the importance of timely reporting of offences and assured necessary legal assistance to the victims.

The programme witnessed active participation from members of the tribal community, who appreciated the initiative taken by DLSA Srinagar in spreading legal awareness and empowering marginalized sections of society.

SWD Srinagar conducts PMMVY registration drive

Department of Social Welfare (SWD), Srinagar, through SANKALP-Hub for Empowerment of Women (Mission Shakti), successfully organized a registration drive under the Pradhan Mantri Matru Vandana Yojana (PMMVY) at LD Hospital Wazir Bagh, Gousia Hospital Khanyar, and JLNM Hospital Rainawari.

The primary objective of the drive was to identify and enroll eligible pregnant women and lactating mothers under PMMVY, ensure last-mile delivery of

maternity benefits, and enhance institutional outreach of the scheme. The drive also aimed at creating awareness among beneficiaries regarding the financial assistance, eligibility conditions, and procedural requirements of the scheme.

During the drive, beneficiaries visiting OPDs, antenatal clinics, and maternity wards were mobilized, counseled, and guided through the registration process. On-the-spot registrations were carried out with the assistance of concerned health functionaries to ensure accuracy and timely enrolment. As a re-

sult, 51 eligible beneficiaries were successfully registered under PMMVY across the three hospitals.

The staff of SANKALP-HEW Srinagar coordinated closely with medical officers, nursing staff, and frontline health workers to facilitate smooth implementation of the drive.

Special emphasis was laid on ensuring proper documentation, Aadhaar seeding, and verification to avoid future grievances and delays in benefit disbursement.

The registration drive contributed significantly to improving awareness, strengthening institutional

convergence between the Social Welfare and Health Departments, and increasing the enrolment rate under PMMVY. The proactive support and cooperation of hospital authorities, health personnel, and field staff played a pivotal role in the successful conduct of the initiative.

Such drives will continue to be organized in the future to ensure maximum coverage of eligible beneficiaries, promote maternal health and nutrition, and further strengthen the effective implementation of women-centric welfare schemes under Mission Shakti.


DC Baramulla chairs DLIC Meeting; Approves 458 cases under Mission Yuva Programme

Bandipora gears up for Wular Bird Watch Festival

Deputy Commissioner (DC) Bandipora, Indu Kanwal Chib, today chaired a meeting to review preparations for the WUCMA-centred Wular Bird Watch Festival, scheduled between 9th-14th February, aimed at promoting eco-tourism and creating diversified livelihood opportunities for local communities.

The meeting was informed that all necessary instructions have been issued to the concerned departments.

Eco-guides and homestays are in readiness, while students have been trained to support festival activities. It was also apprised that police verification of all stakeholders involved in the festival has been completed.

During the meeting, the Deputy Commissioner said that a temporary market will be established for NRLM groups, Cooperative Societies and Fisheries to showcase local products in-

cluding lotus stem and water chestnuts. Shikara rides will also be available for visitors.

Five prominent locations have been identified for festival activities, with reception centres and camps at Banyari and Nadial, and stalls at S.K. Payeen and Watlab.

The DC directed the constitution of a Rate Fixation Committee to finalize rates for eco-guides, shikara rides and fisheries-related services. She also reviewed transport arrangements to

ensure smooth movement during the festival.

On the occasion, the DC stressed the importance of promoting sustainable tourism around Wular Lake by highlighting its rich biodiversity and the seasonal arrival of migratory birds.

She emphasized that the Wular Bird Watch Festival should not only enhance environmental awareness but also serve as a platform for generating sustainable and diversified livelihood opportunities for local

communities. DC Ramban Reviews Revenue Deptt Functioning

Deputy Commissioner Ramban, Mohammad Alyas Khan, today chaired a comprehensive meeting to review the overall functioning of the Revenue Department.

The meeting was attended by Additional Deputy Commissioner Varunjeet Singh Charak; Assistant Commissioner Revenue Shokat Hayat Mattoo; SDM Banial Mohammad Naseeb Bajran; SDM Gool Imtiaz Ahmed; SDM Ramsoo Sayad Mazar Hussain Shah, besides Tehsildars, Block Development Officers, and other Revenue officials.

During the meeting, detailed deliberations were held on key issues, including update of old revenue records, cadastral mapping, generation and distribution of Property Cards under the SVAMITVA Scheme, disposal of court cases, transfer of land for

installation of 4G towers, timely submission of compliance reports in court cases, utilization of funds released under Revenue Capex for the year 2025-26, and timely execution of summons.

The Deputy Commissioner directed the Tehsildars and BDOs to ensure that no residential or commercial construction is allowed in their respective jurisdictions without prior approval from the competent authorities, emphasizing strict enforcement of land and building regulations.

He further directed the Tehsildars to extend necessary assistance to BDOs in motivating beneficiaries to commence and complete construction of their PMAY houses without delay, ensuring timely achievement of housing targets.

The Deputy Commissioner also reviewed the public services being delivered by the Revenue Department and conducted a tehsil-wise assessment of the progress in all other assignments.

Appreciating the efforts of Revenue staff in the digitization of revenue records, the Deputy Commissioner stressed the need to maintain accuracy, transparency, and accountability while carrying out the

Emphasizing timely and transparent public service delivery, the Deputy Commissioner instructed officers to promptly address public grievances and reiterated the importance of citizen-friendly functioning of all revenue and administrative units to strengthen public trust and enhance overall administrative efficiency.

Meanwhile, the Additional Deputy Commissioner also suggested various measures to further improve public grievance redressal mechanisms and streamline service delivery.
