He also informed that the tender process for the procurement of election material for panchayat polls had been completed and was underway for DDC elections.

He said 30,000 ballot boxes had been purchased and distributed to districts, while an MoU was signed with the Madhya Pradesh State Election Commission for providing 7,000 multi-post electronic voting machines for ULB elections.

Highlighting reforms in the panchayati raj system, Omar said the Union territory had operationalised a three-tier structure with elections conducted for 4,291 sarpanches and 33,597 panchs, besides the constitution of BDCs and DDCs.

He said the government had undertaken construction of 600 panchayat bhawans with internet connectivity and trained over 7.25 lakh participants in governance, planning and financial management between 2022 and 2025. "Amendments to the laws have ensured reservation for women, scheduled castes, scheduled tribes and other backward classes," he added.

Omar said that digital platforms, such as eGramSwaraj and initiatives like the SVAMITVA scheme, had been introduced to enhance transparency, accountability and provide a record of rights to rural households.

Rs 19 cr worth cocaine seized

ashram, had deposited fake currency notes, having a face value of Rs 9,000, according to officials.

Officials said a probe was launched after registering an FIR under relevant sections of BNS at Bari Brahmana police station. During probe, police obtained bank account statements of the accused who was presently residing at Jalalabad in Sunjwan area of Jammu.

Scrutiny of the accounts revealed balances of about Rs 18 lakh in J&K Bank and Rs 2.40 lakh in PNB, officials said, adding that a special investigation team was set up by the SSP, Samba, to ascertain the source of the bank balances, given that the accused was a driver by profession.

During questioning, the accused disclosed that he was selling cocaine since long and had earned the said amount through drug trafficking, officials said.

Police recovered two packets of cocaine, weighing approximately 1937.80 grams, in cardboard boxes wrapped with cello tape hidden in the garage at his workplace at Bari Brahmana, officials said, adding relevant sections of NDPS Act were then added in the case.

More arrests and recoveries were expected at the disclosure of the arrested drug peddler, officials said.

Meanwhile, two drug peddlers were arrested along with about 55 grams of heroin during vehicle checking at Chenani in Udhampur district in the morning, officials said.

The accused were on way to Srinagar from Jammu in a car when they were intercepted by police, leading to the recovery of the narcotic substance, the officials added.

Try not to make AI or mobile phone master: Modi to students

afraid of emerging technologies such as Artificial Intelligence, but use them to hone their skills and improve potential.

"We should not try not to make AI or mobile the master; some kids do not eat food unless they see the smartphone. We can use AI efficiently," he said.

The prime minister also urged students to practice previous papers and have a good sleep to perform better at examinations.

"You will never feel tense after preparing well for exams. A good night's sleep will keep you cheerful for the rest of the day," Modi said.

The prime minister said he felt good to see that the students of Classes 10 and 12 in the country can also carry the dream of Viksit Bharat 2047 in their minds.

"This is a matter of great happiness for me. We should adopt the habits of developed countries-we should turn off engines at red lights, we should not leave food, and should reduce wastage... Discipline is very important in our life..." The prime minister recalled the role of his teachers in his days as a student and their insistence on exercise to remain healthy.

"If you ask any great person, they will say that their mother and teachers helped shape their life," Modi said.

The first episode of the ninth edition of Pariksha Pe Charcha was aired last week where the prime minister advised students to listen to everyone's advice but change lifestyle pattern only when they want to. He also told them that education should not feel like a burden and advised

them to focus not only on marks but also on improving life.

Launched in 2018, Pariksha Pe Charcha began as student interaction in townhall format before expanding into one of India's largest education engagement exercises. Registrations rose from about 38.8 lakh in 2023 to 2.26 crore in 2024, before touching 3.53 crore in 2025 - a milestone that earned the programme a Guinness World Record. The ninth edition broke the previous record with over 4.5 crore registrations.

here, he said thyroid disorders must be viewed not merely as clinical conditions but as a national concern linked to human productivity, demographic strength, and the broader task of nation building.

Dr Singh said that undiagnosed and untreated thyroid conditions, particularly hypothyroidism, impact energy levels, workforce efficiency, and long-term national output, especially in a country where over 70 pc of the population was below 40 years of age.

The conference saw the participation of eminent endocrinologists, senior faculty members, nuclear medicine specialists, surgeons, and researchers from premier medical institutions across the country.

Referring to the estimated 42 million Indians living with thyroid disorders, Dr Singh said that the scale of the challenge demands proportionate research attention and public health response.

He stated that hypothyroidism affects nearly 11 percent of the adult population, with a substantial number remaining undiagnosed or untreated. He drew attention to the serious implications of undetected hypothyroidism during pregnancy, which can lead to congenital hypothyroidism and irreversible neurodevelopmental consequences in children if not addressed through timely screening and intervention.

MHA forms panel to deal digital arrests

mendations made by the Amicus Curiae should also be considered by the concerned quarters alongside the directions already issued on December 1 last year.

The status report filed by the MHA on January 12 detailed a multi-agency offensive involving the CBI, RBI, Telecom Department and top IT ministries to dismantle transnational syndicates using forged documents and "digital arrest" tactics to siphon funds from innocent citizens.

Acting on the directions of the bench, the report said the CBI has officially taken over the investigation into a high-profile fraud case of Delhi where the victim, a 76-year-old widowed pensioner, was allegedly duped of Rs 1.64 crore through a "digital arrest" scam where she was threatened by impersonators using fake documents.

The CBI informed the court that these scams are often perpetrated by "organised and transnational cybercrime syndicates" and that the agency is now utilising INTERPOL channels to dismantle international modules. The MHA has established an IDC under the chairmanship of the special secretary (internal security).

The panel includes joint secretary-level officers from the Ministry of Electronics and Information Technology (MeitY), Department of Telecommunications (DoT), Reserve Bank of India (RBI), Ministry of External Affairs (MEA) and Indian Cyber Crime Coordination Centre.

It said the committee is mandated to identify legislative gaps, suggest corrective measures and ensure "time-bound compliance" across the banking and telecom sectors.

The court-appointed amicus curiae, senior advocate N S Nappinai, has proposed a landmark shift in victim relief and suggested that releasing frozen proceeds to victims based on portal complaints and indemnity bonds, without mandating a formal FIR registration in all cases.

The amicus also suggests that platforms like WhatsApp and Telegram limit the duration of video calls from unknown numbers to prevent prolonged coercion.

The government has requested a one-month extension from the Supreme Court to consolidate inputs from all stakeholders.

The committee's next focus will be on strengthening the "Adjudication Mechanism" under Section 46 of the IT Act and finalising a national online portal for cyber-crime adjudication.

"In view of the foregoing facts and circumstances, it is most respectfully prayed that this Hon'ble Court may be pleased to grant a period of at least one month to enable the respondents to obtain inputs from the remaining members of the Inter-Departmental Committee and to undertake further 4 deliberations thereon, so as to place a consolidated and considered outcome before this Hon'ble Court," the MHA said in its status report.

De-freezing of teachers' posts on the anvil: Sakina

Administrative Council in 2018, and the government was actively working to de-freeze these posts so that fresh recruitment was expedited in the department.

She informed the House that 594 posts of lecturers in 27 disciplines had been referred to JKPS, and 727 non-teaching & 43 MTS posts had been referred to finance department for revival/concurrence.

Regarding filling up of vacant posts of teachers, she apprised that all these posts had been frozen for transition of RRETs, Teacher Grade II/III to clear the salary issue of teachers who were engaged under SSA.

She also said that in 2025-2026, a total of 258 senior lecturers were elevated as in-charge principals and 56 PG masters/teachers were elevated as in-charge lecturers.

She added that 551 PG masters/teachers were placed as in-charge headmasters and a proposal for placement of more than 500 additional masters as headmasters was currently under process in the department.

She said that 80 Headmasters were elevated as in-charge Zonal Education Officers. In non-gazetted cadre, she said that 1170 Teachers have been elevated as Masters in 2025-26.

Regarding Udhampur district, she said that 42 positions of Principals out of 43, 8 posts of ZEOs out of 11 and

243 posts of lecturers out of 538 have been filled in the district. She added that engagement of CRCs as well as rationalisation of staff is under process to overcome shortage of staff in schools across J&K.

The minister said that the Pupil Teacher Ratio in respect of Schools of Udhampur West constituency is 1:16, which shows sufficient staff is available as per enrolment. She added that for academic quality enhancement subject specific teachers, CRCs, online classes are being arranged.

She attributed the improved performance of Jammu Division in the 10th and 12th board exams to the government's initiatives, saying these efforts have led to a notable academic upswing, with results surpassing those of previous years.

"It is unfortunate that instead of honouring that mandate, you are putting the entire J&K on sale today," he said.

Para urged the CM to rethink the scheme, cautioning that J&K should not be pushed towards a situation similar to the one faced by "failed states like Sri Lanka and Pakistan".

Deputy Chief Minister Surinder Choudhary led the counter attack and rejected the allegations, accusing the opposition leaders of "playing to the gallery" and politicising a financial assistance framework intended for development.

While the chair was trying to pacify the situation and was asking a National Conference member to speak, BJP objected and tried to enter the well, alleging that they were not being given adequate time to speak and later moved out of the House.

As the disorder continued, Gul adjourned the House half-an-hour before the scheduled time till 2.30 pm.

Raising concerns over governance and budgetary performance, the PDP legislator said while people had high expectations from the NC government, Jammu and Kashmir was passing through "the most unprecedented times".

"There is no doubt that the challenges before the NC government are immense, and it is also true that such challenges have not been faced by any government in the past seven decades," he said.

He acknowledged that the present government was operating under serious constraints but said public expectations remained high and could not be ignored.

Referring to last year's budget of Rs 1.40 lakh crore, he said nearly Rs 40,000 crore was earmarked for revenue expenditure while capital expenditure stood at around Rs 7,600 crore.

"With barely 30 days left for the financial year to end, I want to know whether the government is capable of spending nearly Rs 1 lakh crore within this short period," Para said.

He claimed that only about 12 per cent of expenditure had been achieved so far and alleged that around 100 projects recorded zero spending, including in critical sectors such as agriculture, horticulture, health and education.

He also described cancer as a "silent pandemic" claiming thousands of deaths without adequate response and questioning the silence of the government on this issue.

The legislator further raised concerns over the closure of 215 schools linked to banned Jamaat-e-Islami, affecting nearly 50,000 students, and sought a detailed explanation for the decision.

He pointed out that there was no allocation for a National Law University in the budget and criticised the government for failing to take a decision on setting up deemed universities in all 20 districts as an effort to prevent targeted attacks on Kashmiri students outside J&K and the alleged failure of the government to protect them.

He also flagged rising diesel and transport costs, mounting financial pressure on the population, and the lack of focused support for orphans and other vulnerable sections.

In this context, Mission YUVA was highlighted as a transformational initiative aimed at promoting entrepreneurship across Jammu and Kashmir. Out of these, Detailed Project Reports (DPRs) for nearly 52,875 applicants had been prepared through Small Business Development Units (SBDUs). ceremony of the three-day division-level 'Bastar Pandum 2026' cultural event at Jagdalpur, the headquarters of Chhattisgarh's Bastar district, Shah reiterated that the Naxal menace will be uprooted completely from the nation by March 31.

He appealed to Naxalites to surrender and join the mainstream, promising them dignified rehabilitation.

"The Maoist rehabilitation policy of the Chhattisgarh government is the most attractive," the minister asserted.

He also expressed concern over the fact that the remaining Naxals still holding out included young tribal girls.

"They must be sent for rehabilitation as their whole lives lie ahead of them," Shah said.

Assuring that surrendered Naxals would not face any harm, Shah also warned that those who continue to fire bullets, plant IEDs (Improvised Explosive Devices) and torch schools and hospitals will not be spared.

"Armed violence will be met with a firm response. If someone holds weapons, the response will also be with weapons. Maoism never benefitted any society and spread destruction wherever it existed, including nations like Colombia, Peru and Cambodia," he said.

"We do not want to fight with anyone. Our fight is to protect our tribal brothers and sisters. When IEDs are planted, innocent tribals and children can be killed or permanently disabled. Where does this cruelty come from?" Shah said while urging the remaining Naxalites to lay down their arms.

Maoists shut down schools for decades, depriving generations of education and creating large-scale illiteracy, he rued.

"But Bastar is now on the path of fast development, with schools reopening, roads being built, mobile towers installed, post offices opened, and electricity and drinking water being extended to villages. It is our resolve that Bastar will become the country's most developed tribal-dominated division within the next five years," Shah said.

The government has prepared a roadmap to accelerate development in the Bastar region, comprising seven districts, aiming to provide electricity to all villages by December 2027, ensure mobile connectivity in every village, and open a post office or bank branch within every five km, Shah added.
