tive sessions covering various important topics such as understanding adolescence and physical changes, menstrual health and hygiene, sexually transmitted infections (STIs) and their prevention, safe and responsible behaviour and mental and emotional well-being.

The speakers explained the biological aspects of reproductive health in a scientific and easy-to-understand manner. They also addressed

common myths and clarified doubts raised by students. Special emphasis was laid on maintaining personal hygiene, seeking medical advice when necessary and promoting healthy relationships based on mutual respect and consent. The nursing faculty provided practical guidance and encouraged students to approach health professionals for accurate information rather than relying on misinformation.

The event concluded with a vote of thanks delivered by Shivani Charak from semester VI, expressing gratitude to the resource persons, organising committee and students for their enthusiastic participation.

The CDR/FDR/BG shall be valid for 45 Days beyond the bid validity period. The original instruments in respect of cost of documents, EMD and relevant documents of L1 be submitted to the Executive Engineer PWD (R&B) Division Jammu East at the time of allotment.

2. The electronic bidding system would not allow any late submission of bids after due date and time as per server time. Bidders may modify their bids by uploading their request for modification before the deadline for submission of bids. For this, the bidder needs not to make any additional payment towards the cost of tender document. For bid modification and consequential re-submission, the bidder is not required to withdraw his bid submitted earlier. The last modified bid submitted by the bidder within the bid submission time shall be considered as the bid. For this purpose, modification/withdrawal by other means will not be accepted. In online system of bid submission, the modification and consequential- submission of bids is allowed any number of times. The bidders may withdraw his bid by uploading their request before the deadline for submission of bids; however, if the bid is withdrawn, the re-submission of the bid is not allowed. No bid shall be modified or withdrawn after the deadline of submission of bids.

3. The date and time of opening of Financial-Bids shall be notified on Web Site [www.jktenders.gov.in](http://www.jktenders.gov.in) and conveyed to the bidders automatically through an e-mail message on their e-mail address. The Financial-bids of responsive bidders shall be opened online in the Office of Executive Engineer PWD (R&B) Division Jammu East. The date for same shall be intimated separately.

4. The bids for the work shall remain valid for a period of 120 days from the date of opening of Technical bids.

5. **The earnest money shall be forfeited, if :-**

a) Any bidder/tenderer withdraws his bid/tender during the period of bid validity or makes any modifications in the terms and conditions of the bid.

b) Failure of Successful bidder to furnish the required performance security within specified time period after issue of letter of acceptance.

As part of commitment of Jammu Municipal Corporation for marinating environmental sustainability and public health, Public is hereby informed about the proper storage and disposal procedures for Domestic Hazardous Waste (DHW), Electronic Waste (e-waste) and Domestic Sanitary Waste and to make collective effort to promote a clean and sustainable environment by implementing following measures to ensure the responsible management of domestic hazardous waste (DHW), electronic waste (e-waste), and domestic sanitary waste at the household level.

**Storage Guidelines:**

- Domestic Hazardous Waste (DHW):
- Please store DHW such as batteries, CFL bulbs and expired medicines in a separate, clearly labeled container.
- Keep DHW out of reach of children and pets.
- Do not mix DHW with regular household waste.
- Domestic Sanitary Waste:
- Dispose of sanitary waste such as diapers and sanitary napkins in a sealed bag.
- Avoid flushing sanitary waste down toilets to prevent blockages.
- Electronic Waste (E-Waste): This is in accordance with E-waste (management) Rules, 2016 notified vide GSR No. 338(E) dated 23rd March 2016
- Separate e-waste items such as old cell phones, computers and electronic accessories.
- Store e-waste in a designated area to prevent damage and contamination,
- Handover Process:
- Residents are encouraged to hand over their Domestic Hazardous Waste, e-waste and domestic sanitary waste to the waste collection authority (Channelizers) at nearby Reduce, Reuse & Recycle (RRR) Centers established by Jammu Municipal Corporation.

**SHOBA YATRA ROUTE: -**

"RANBIRESHWAR TEMPLE WILL PASS THROUGH INDIRA CHOWK- HARI MARKET- SHRI RAGHUNATH BAZAR – BHARAT MATA CHOWK - OLD HOSPITAL ROAD- PURANI MANDI - LINK ROAD - JAIN BAZAR- CHOWK CHABUTRA - PACCA DANGA- MOTI BAZAR- PARADE CHOWK AND THE YATRA WILL CULMINATE BACK AT SHRI RANBIRESHWAR TEMPLE AT SHALAMAR ROAD."
