The Director emphasized that survival and success in today's competitive world depend on acquiring skills. He encouraged participants to register for suitable training programmes to enhance their employability

and self-employment opportunities.

Faculty members of SBI RSETI informed participants that a computer training batch will commence shortly. They requested Panchayat representatives to sponsor two to four candidates from Kundal Panchayat for the free programme.

A representative from CFL Paddar Saqib discussed important social security schemes such as Pradhan Mantri Suraksha Bima Yojana (PMSBY), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY) and Atal Pension Yojana (APY) along with other government-sponsored initiatives.

JMC Commissioner conducts sanitation and anti-encroachment drive in wards 49, 74

Commissioner, Jammu Municipal Corporation (JMC), Dr Devansh Yadav today conducted an extensive inspection of Ward Nos 49 and 74, covering Narwal, Bathindi, Sunjwan, Chowadi and adjoining areas to review sanitation standards and address illegal encroachments.

During the tour, the Commissioner assessed the cleanliness of main roads, inner lanes, drains and public spaces. He reviewed the progress of ongoing developmental works and examined the upkeep of civic amenities.

Emphasising the importance of hygiene, Dr Yadav directed officials to ensure regular garbage lifting, strict waste segregation at source and timely desilting of drains to prevent waterlogging.

He stressed the urgent cleaning of deep drains and nullahs, particularly those



subject to heavy flow during the rainy season and instructed that preventive measures be taken in advance.

As part of the enforcement drive, illegal encroachments on roads and footpaths were removed and unauthorised roadside stalls were cleared to restore public spaces. Encroachments on government land in the Sunjwan area were dismantled on the spot.

The Commissioner appealed to citizens to cooperate with the Corporation by adopting responsible waste disposal practices. Among those accompanying the Commissioner were Joint Commissioner (Health and Sanitation) Abdul Sattar, Deputy Commissioner (South) Chand Singh, Health Officer Dr Vinod Sharma, Executive Engineer Yasir Bashir Kichloo and Chief Transport Officer Balkar Anguana.

Addressing officers, Dr Yadav emphasised improved inter-departmental coordination and consistent implementation of sanitation measures. He stated that cleanliness drives must be treated as a continuous civic responsibility.

KPDCL observes 'Smart Meter Pakhwada' to promote consumer awareness, Digital Power Services

In a significant step towards strengthening consumer engagement and as a part of a nationwide awareness campaign, Kashmir Power Distribution Corporation Limited (KPDCL) is observing "Smart Meter Pakhwada" across the Kashmir Valley.

The fortnight-long programme, which commenced on February 9, will continue until February 23, 2026. The initiative aims to create awareness among electricity consumers about the benefits, features, and functioning of prepaid smart meters, as well as various billing applications like "smartbs" and "bill sahuliyat+" while encouraging greater adoption of these digital power management tools.

As part of the campaign, help desks and informational kiosks have been established at divisional and sub divisional level throughout the Valley. The camps feature interactive sessions and open discussions, allowing consumers to engage directly with officials and seek clarifications on smart meters. Informative leaflets are being distributed, and live demonstrations are being conducted to explain real-time energy consumption tracking and automated billing features which smart metering offers to consumers.

The campaign is witnessing active participation from senior officers, field engineers, PMA representatives, and the implementing agency, along with encouraging response from



users to monitor their electricity consumption in real time. Through this digital platform, consumers can conveniently access usage data from their homes and gain advance insights into their electricity bills.

KPDCL has urged all electricity consumers to actively participate in the awareness camps and take full advantage of the initiative.

The corporation emphasized that smart meters represent not merely a technological upgrade, but a vital step toward building a reliable, efficient, and future-ready power distribution system in the region.

DC Kathua chairs meeting with Revenue Officers of Hiranagar Sub Division

Deputy Commissioner Kathua, Rajesh Sharma today chaired a meeting with Revenue Officers of Hiranagar Sub Division to review the functioning of the Revenue Department and assess progress on key assignments.

The meeting was attended by SDM Hiranagar Phulail Singh, Tehsildar Hiranagar Anoop Sharma, Tehsildar Marheen Lekh Raj, Tehsildar Dinga Amb Amit Upadhyay and other revenue officials of the Sub Division.

During the meeting, the Deputy Commissioner laid special focus on digitisation of Jamabandis and directed the officers to ensure that the process is carried out in a time-bound and error-free manner. He stressed that digitisation is essential for enhancing transparency, improving accessibility of land records and minimising disputes.

The DC instructed the Tehsildars to closely monitor the progress of scanning, verification and up-



loading of revenue records and ensure that pendency, if any, is cleared expeditiously.

He also directed for proper coordination among field functionaries to maintain accuracy and authenticity of records.

Emphasising time-

bound public service delivery, the Deputy Commissioner asked the officers to strictly adhere to timelines prescribed under the Public Services Guarantee Act and ensure prompt disposal of revenue-related services such as issuance of certificates, mutations and

other public services. He further directed the officers to hold regular public interaction camps at the Tehsil level to address grievances of the people and to ensure responsive and accountable administration at the grassroots level.
