

Shraddha Kapoor To Collaborate With Vicky Kaushal For Mahavatar? Here's What We Know

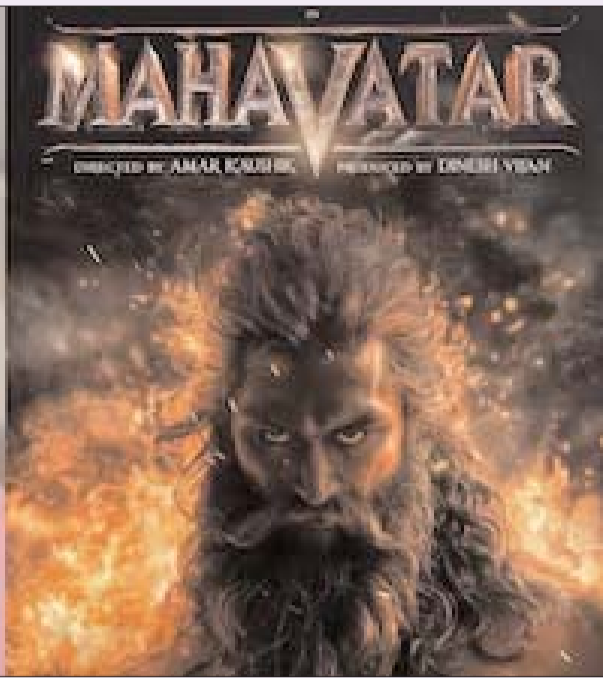


Shraddha Kapoor is reportedly in talks to star opposite Vicky Kaushal in the upcoming mythological film Mahavatar. The news has created a buzz among fans about a fresh on-screen pairing. While there has been no official confirmation yet, a report suggests that the actress is in talks with the makers.

Mid-day has quoted a source saying, "Shraddha fits the brief perfectly. The team was keen on someone who brings star value and presence. Plus, the Vicky-Shraddha pairing will be fresh, and the makers are confident this combination will resonate with the audience." Earlier, reports also suggested that Deepika Padukone is in talks for the mythological drama. But looks like things did not fall in place. Well, it was never confirmed.

Earlier, source told mid-day, "The actor cannot begin his physical prep as he is currently shooting Sanjay Leela Bhansali's Love & War, in which he sports an athletic look. For Mahavatar, he will need to build a heavy frame like that of a wrestler, complete with a rugged look and long, matted hair. After Love & War reaches the finish line in April, the actor will adopt a new diet plan and workout regime to attain the required look."

In 2024, Vicky Kaushal announced the project and



shared the first look of Mahavatar which immediately went viral. Sharing the look, the actor wrote, "Dinesh Vijan brings to life the story of the eternal warrior of dharma! Vicky Kaushal stars as Chiranjeevi Parashurama in #Mahavatar, directed by Amar Kaushik. Coming to cinemas - Christmas 2026!"

The actor is currently shooting for Love & War with Sanjay Leela Bhansali

As per reports, Shraddha Kapoor will be next seen in Eetha, a biopic inspired by the life of Maharashtra's celebrated Tamasha performer, Vithabai Narayangaonkar. After this, she will jump into the shoot of Naagin. As per Mid-Day, Shraddha will finish Eetha shoot in March this year and in April, she will begin shooting for Naagin.

"Shraddha has been deeply invested in Eetha. The role is physically gruelling and emotionally intense, but she is keen to finish the film within the schedule. The makers are confident of wrapping by March," a production source told the portal.

"Naagin has been in development for a long time, and the team wanted to get everything right - from the VFX design to the casting. With Shraddha locked in, the rest of the cast has fallen into place.

Tiger Shroff Sells Pune Apartment For Rs 8.87 Crore, Clocks Over 18 Per Cent Profit



Real estate moves and Bollywood stars... always a combo that grabs attention. This time, it's Tiger Shroff making headlines, not for a film, but for a property deal that's turned out to be quite a profitable one.

According to property registration data accessed by Zapkey, the actor has sold his apartment in Pune's Hadapsar area for ₹8.87 crore. The property is part of the YOO Pune development by Panchshil Realty. Interestingly, Shroff had purchased the same unit in March 2024 for ₹7.5 crore, resulting in a gross return on investment of approximately 18.3%.

The apartment, spread across 4,249 sq ft, was sold at a rate of ₹20,891 per sq ft. The transaction, registered on

March 31, 2026, included three parking spaces. Official records show that stamp duty exceeding ₹62 lakh and a registration fee of ₹30,000 were paid as part of the deal.

Documents further reveal that the buyer is Cherise (India) Private Limited. The company had previously leased the same apartment from Shroff at a monthly rent of ₹3.5 lakh for a tenure of five years, indicating an existing association between the two parties.

Attempts to seek a comment from Tiger Shroff were unsuccessful at the time of publishing. An email has also been sent to Cherise (India) Private Limited, and the report will be updated if a response is received.

Tiger Shroff, son of veteran actor Jackie Shroff, has carved a niche for himself in the Hindi film industry with his action-packed roles and dance performances. He is known for films such as Student of the Year 2 and War, and has also built a strong following for his fitness and martial arts skills.

Meanwhile, Shroff is not the only Bollywood name active in the real estate space. Over the

past year, several celebrities have sold high-value properties. Akshay Kumar reportedly sold multiple assets worth over ₹100 crore in 2025, while Amitabh Bachchan also made headlines for property deals close to ₹100 crore during the same period.

Actor Preity Zinta, too, has been in the news for her real estate transactions. In March 2026, she sold an apartment in Mumbai's Pali Hill area in Bandra for ₹18.50 crore, as per documents accessed by CRE Matrix. Earlier, in November 2025, she had sold another 1,474 sq ft apartment in the Rustomjee Parishram building for over ₹14 crore.

Delnaaz Irani Says She Left Marriage With Rajeev Paul Without Alimony To Protect Her Peace

Sometimes, the hardest choices aren't about winning but about walking away. Actor Delnaaz Irani is now looking back at one such decision from her past, and her reflections are as honest as they are quietly powerful.

In a recent appearance on The Male Feminist, Delnaaz opened up about her separation from Rajeev Paul, shedding light on the emotional toll of their split and the choices she made during the divorce. The two were married for 14 years before separating in 2010, though she clarified that the relationship had begun to unravel much earlier.

Speaking about that phase, she said, "Many discussions happened between us as a couple about what's not working. But in a relationship, people take each other for granted, and probably that happened with me. My partner kept taking me for granted, probably he did not realise that the matter was going to turn serious. There was nothing like divorce in my dictionary. From where I come, a middle-class, Parsi family, my parents were together for so many years, even my nana-nani. We were never exposed to that concept, despite being open-minded and liberal. That does not mean that we would take divorce lightly. The emotional turmoil was a struggle for the longest time."

Delnaaz also revealed that while the separation became public in 2010, the strain in the marriage had already been building. She chose to keep the situation from her parents during that time. The period was further marked by personal loss, as her father suffered a heart attack in 2010 and passed away in 2011.

Addressing the legal and financial aspects of the divorce, the actor made it clear that she chose not to pursue alimony. "I never got any-



thing. The divorce was messy because one person wanted it and the other did not. I chose my peace over everything. You have to pick up the broken pieces and live life again," she said.

Delnaaz and Rajeev first met on the sets of Parivartan in 1993 and tied the knot in 1998. Their divorce was finalised in 2012. Interestingly, the former couple appeared together on Bigg Boss 6 shortly after their separation, bringing their personal equation into the public eye once again.
