Subject: Fixation of seniority of Smt. Sarita Raina in the combined updated/final seniority list of 10 + 2 Lecturers of School Education Department and consequential placement as Senior Lecturer.

NOTICE

WHEREAS, Smt. Sarita Raina, Retired Lecturer Zoology, approached this Department through the medium of a representation, seeking her determination / fixation of her seniority list of +2 Lecturers issued vide Government Order No. 1073-Edu of 2013 dated 30.12.2013, as well as her consequential claim for placement as Senior Lecturer;

AND WHEREAS, the matter has been examined in detail and upon consideration of the relevant records, it has been found that her counterparts, both senior and junior in the regularization order, where included in the final seniority list of +2 Lecturers and considered for placement as Senior Lecturer, whereas the applicants name did not figure in the seniority list;

AND WHEREAS, in order to consider the applicant's claim for placement as Senior Lecturer at par with her junior counterpart, it is necessary to determine and fix her position in the final seniority list of +2 Lecturers issued vide Government Order No. 1073-Edu of 2013 dated 30.12.2013;

AND WHEREAS, upon consideration of the relevant records, it has been found that the applicant is entitled to be assigned **Seniority No. 299-A** in the combined updated/ final seniority list of 10 + 2 Lecturers issued vide Government Order No. 1073-Edu of 2013, dated 30.12.2013;

AND WHEREAS, the applicant is required to be placed at **Seniority No. 299-A**, between her senior counterpart, Mehraj-Ul-Din Paul, holding Seniority No. 299, and her junior counterpart, Mahraj Krishen Bhan, holding Seniority No. 300, in the said final seniority list.
